

# BIBLICAL HOLY LAND TOUR, JUNE 25 – JULY 5, 2023

## Terms and Conditions

### Tour includes:

- 10 nights accommodations (double occupancy)
- Full buffet breakfast and dinner daily while in Israel
- Some group lunches will be included, others on your own
- Knowledgeable English speaking guides
- Deluxe motor coaches, with A/C and professional drivers
- Bible Studies and prayer daily on location
- Evening Shabbat meal with special BFP speakers
- Evening teaching with Orthodox Jewish Rabbi
- Opportunity to participate in a service project with Bridges for Peace.
- Opportunity to be baptized in the Jordan river at Yardenit (\$10 cost)
- Entrance fees into sites plus taxes
- Luggage handling at hotels in Israel, tips (except house-keeping staff, bus driver, tour guide)



### Tour Does Not include:

- Travel and medical insurance plan with Covid coverage is highly recommended. We suggest [travelguard.com](https://travelguard.com) or [allianztravelinsurance.com](https://allianztravelinsurance.com).
- Transportation to and from Israel, Ben Gurion Airport, Israel.
- Miscellaneous fees, items of a personal nature such as passports, laundry, beverages, baggage fees.
- Any extra help needed such as an unscheduled trip to or from the hotel, taxis
- Any mandated health tests required to travel (currently covid vaccine & testing is **not** required)

**Cancellation fees:** Cancellation notice must be received in WRITING and is only valid as of the day it is received.

Up to 91 days prior of departure - \$300  
60 – 45 days prior to departure - \$1500

90 – 61 days prior to departure - \$1000  
Less than 45 days prior to departure – 100 %

*No refund for any unused portion of the tour once the tour has begun.*

***NOTE:*** We will make every effort on your behalf to refund what is due you. However, if there are additional air or hotel cancellation charges or other out of pocket expenses, these will be passed on to you. **A minimum of \$300 is non-refundable. We highly recommend travel insurance. If this trip is canceled by the airline due to Covid or other reason, all other refunded monies will be returned.**

**Documentation** A VALID PASSPORT through January 1, 2024 required. Visas are not required with a US Passport. **This form must be filled out online within 10 days of arrival in Israel:** <https://corona.health.gov.il/en/flights/>

**Late registration and fees:** A deposit of \$500 per person is required along with a completed registration in order to secure your reservation and is based on availability. If registering after April 1, full payment is required at registration. Hotel prices may cause the price to be higher for passengers joining the trip after reserved rooms are taken or the deadline of May 1, 2023.

**Luggage/baggage:** Biblical Holy Land Tour (BHT) accepts no responsibility for damage or loss of luggage or belongings. Travel insurance is strongly recommended. Please refer to their details regarding coverage for luggage/baggage.
